### **APPENDIX A: PUBLIC LAW 280 JURISDICTION**

Public Law 280 The general jurisdictional scheme was altered in California by Public Law 280 enacted by Congress in 1953 PL 280 transferred federal criminal jurisdiction and conferred some civil jurisdiction on states and state courts in the six mandatory Public Law 280 states, which includes California
